Police Operations Report:

Chief Csanyi reported highlights of the month's activities by the department.

DPW Operations Report:

DPW Superintendent Thomas Buschlen reported the month's activities and presented a quote for a new street light pole explaining that Medler Electric was able to find the style we currently have.

A motion was made by Tibbits; second by Wehner to approve the purchase of 2 downtown street light poles from Medler Electric Co. at a cost of \$1,907.75 each. All Ayes. Motion Carried.

A motion was made by Hill; second by Tibbits to approve the purchase of 10 downtown LED street lights from Medler Electric Co. at a cost of \$3,450.00. All Ayes. Motion Carried.

President LePage reviewed a letter from the City of Caseville setting the 2024 Water Rate at \$10.20 per thousand gallon.

President LePage reviewed the Performance Resolution for Municipalities from MDOT (Michigan Department of Transportation).

President LePage explained that we have received \$10,000 from the Huron County Community Fund to be used for a new Playscape. He would like to involve the Pigeon Lion's and Pigeon Rotary in this. Because of this he would like to appoint a committee to explore the Playscape. The committee will consist of President LePage, Chairperson Shelly Gunden, Member Kent Tibbits, Village Clerk Corrion and a Rotary Adhoc Member to be announced.

President LePage explained that they had been contacted from WNEM TV5 about advertising the Pigeon Event Center. It would consist of a 2-minute segment that allows you to share who you are and what you offer to be run a various time on WNEM. The Silver Package would cost \$750.00.
