Public Input:

Huron County District 3 Commissioner Todd Talaski updated the council on various activities of the county.

Ken Light complained about his neighbor's quantity of dogs.

Presentation of the 2017/18 Village Audit, Brian Hazard, Nietzke & Faupel, PC:

Brian Hazard of Nietzke & Faupel presented the village audit for the year ending February 28, 2018 giving the village an unqualified opinion. He noted that the villages General Fund, Unassigned Fund Balance increased by \$10,297.00 to \$584,091.00 which is 70.0% of the General Fund expenditures. The Sewer Fund, ended the year with an Unassigned Fund Balance of \$423,379.00 a decrease of \$846.00. The Water Fund ended the year with a Unassigned Fund Balance of (\$278,663.00) a decrease of \$161,620.00 The only fund to end the year in the red was the Trunkline Fund at (9,075.00) with an Unassigned Fund Balance of \$(11,943.00). Overall the village has a very good year. The General Fund, Unassigned Fund Balance has increased the last ten years despite level or even reduced tax revenues. In overall the village is moving in the right direction.
